

# Latest Update on COVID-19 and the Real Estate Industry

The most important thing to remember as a REALTOR® is to **protect your client**, and that means putting their best interests first. The NAR Code of Ethics and the MLS Clear Cooperation Policy still apply to all real estate business practices and transactions.

We have had many members raise concerns over legislation in Colorado to deem real estate services non-essential. Please note that the Colorado General assembly is currently **suspended** so **no legislation is being worked on or considered.** The only political activities relate to a governor's power and executive orders or directives.

## **IN THE MEANTIME**

Normal business practices are changing by necessity because of this pandemic. It's very important to keep communication open, not only with your clients and fellow REALTORS®, but with the third-party service providers who are working with you and your clients during the real estate transaction.

Remember that real estate transactions **are still being done**, but it is being done in a modified manner. In order to ensure the protection of everyone, **please exercise the following:**

  - Please do not schedule simultaneous showings with other agents and buyers in a property at the same time. Respect the recommendation of social distancing.

## **LENDERS & TITLE COMPANIES**

Encourage your clients to keep in regular contact with their lender. The economic landscape is changing rapidly, and their lender can help keep your client informed during the loan process. Find out before it's time to sign for the loan how comfortable your client is with technology. Almost everything can be done



electronically, make use of such technologies as FaceTime, WebEx and Zoom. Contact the lender to find out what alternatives are being offered if your client does not want to complete the loan process online. Many lenders have updated their office policies to include a variety of options that abide by the CDC's recommendations, including limiting the number of people in the office and social distancing.

Call your title company ahead of your closing to find out what options they have for their closings and let your clients choose the best one for them. It might be in person with increased distance, each party being in a separate room, curbside or even by mail. Again, take advantage of the technology if you can. Wipe down and sanitize keys and garage door openers and put in a sealed bag before handing them over.

**Please remember** that in the interest of protecting some of their more at-risk employees, you might be interacting with someone who is working across departments and may not know how exactly you do things. Patience, flexibility, grace, and open communication are key to ensure a successful experience.
